Labor & Employment: Our Labor and Employment attorneys are keenly aware of the unique challenges facing public sector employers in Pennsylvania. Our proactive approach allows municipal leaders to stay in front of issues, rather than waiting to respond to costly litigation. We work with elected and appointed officials to develop policies, procedures, handbooks and general practices to avoid costly and time-consuming litigation.

We help municipalities defend Environmental Rights Amendment claims.
