The last thing a brewery wants to do is change its name or the name of a key product. Therefore, a brewery must use care in selecting a brewery trademark and any trademark used on flagship products. We assist breweries in selecting protectable trademarks by conducting thorough trademark searches so that we can advise a brewery of marks that are likely to result in conflict. Once a brewery settles on a trademark, we assist with filing applications and guiding the mark through the registration process. The craft beer industry is like no other when it comes to trademarks and

brand protection, but we combine our deep understanding of trademark law and our knowledge of the craft beer industry to find reasonable resolutions to trademark disputes. While many trademark disputes can be avoided simply by selecting marks that are not likely to result in conflict, sometimes conflict is unavoidable and a trademark dispute arises.
